3. Determining Decedent's heirs;
4. Construing Decedent's Will, if any;
5. Confirming the acts of the Personal Representative as shown by the Final Account and this Petition;
6. Allowing the Final Account;
7. Determining the persons entitled to distribution of the Estate and their respective interests;
8. Approving settlement of the Estate and  
     Issuing a decree of distribution assigning the Estate to the persons entitled to the Estate.  
    or  
     Directing or approving the distribution of the Estate by the Personal Representative to the persons entitled to the Estate.
9. Granting such other relief as may be proper.
