**NOTICE AND ORDER FOR HEARING  
PURSUANT TO MINN. STAT. § 501C.0203**

IT IS ORDERED AND NOTICE IS GIVEN that a Petition to \_\_\_\_\_ Pursuant to Minnesota Statutes

Mailing a copy of this Notice and Order for Hearing to all persons named in the Petition as having or who may claim to have an interest in the Trust, at their last known addresses by U.S. Postal Service at least 15 days prior to the hearing date, and  
Publishing this Notice and Order for Hearing one time at least 20 days prior to the hearing date in a legal newspaper of \_\_\_\_\_ County, Minnesota.
  - b.  In Personam Jurisdiction  
Giving notice to the current trustees and the Qualified beneficiaries in the same manner as set forth under Rule 4

of the Rules of Civil Procedure by serving a copy of the order for hearing and the petition at least 15 days prior to the hearing unless waived in writing by the current trustees and the Qualified beneficiaries or if a Qualified Beneficiary is a minor or incapacitated notice shall also be given to any representative person in accordance with Minnesota Statutes sections 501C.0301 to 501C.0305, acting on behalf of the Qualified Beneficiary who is known to the petitioner.
