Simply click the link to join the live webcast. You'll see and hear the seminar, and will be able to e-mail questions to the presenter. If materials are available, a link to download, print or review them will become active on Minnesota CLE's homepage one day before the webcast. Adobe Reader may be required and is available for free at <http://get.adobe.com/reader/>

How do I register?
